Accrual of interest on noncash deposits – Interest begins to accrue on the business day you deposit noncash items (for example, checks).

Transaction Limitations – If any withdrawal is made from this account before club maturity then this account may be closed. Your club account balance will be paid out annually in October.

Common Features

Withdrawals from a time account prior to maturity or prior to any notice period may be restricted and may be subject to penalty. See your notice of penalty for early withdrawal.
